GUIDANCE FOR COMPLETING THE CERTIFICATION OF ORIGIN

- FIELD 1** Tick the appropriate box indicating whether the certifier is the exporter, producer or importer.
- FIELD 2** State the certifier's name, title, address (including country), telephone number and e-mail address.
- FIELD 3** Provide the exporter's name, address (including country), e-mail address, and telephone number if different from the certifier. This information is not required if the producer is completing the certification of origin and does not know the identity of the exporter. The address of the exporter shall be the place of export of the good in a Party's territory. The address of the exporter shall be the place of export of the good in a CUSMA/USMCA/T-MEC country.
- FIELD 4** Provide the producer's name, address (including country), e-mail address, and telephone number, if different from the certifier or exporter or, if there are multiple producers, state "Various" or provide a list of producers. A person that wishes for this information to remain confidential may state "Available upon request by the importing authorities". The address of the producer shall be the place of production of the good in a CUSMA/USMCA/T-MEC country.
- FIELD 5** If known, provide the importer's name, address, e-mail address, and telephone number. The address of the importer shall be in a CUSMA/USMCA/T-MEC country.
- FIELD 6a** Provide the HS tariff classification of the good to the 6-digit level.
- FIELD 6b** Provide a description of the good. The description should be sufficient to identify the good covered by the certification. If the certification of origin covers a single shipment of a good, indicate, if known, the invoice number related to the exportation.
- FIELD 7** Specify the origin criteria (listed below) under which the good qualifies as set in annex 4.2 (Originating Goods).

Wholly obtained or produced entirely in the territory of one or more of the Parties, as defined in Article 4.3 (Wholly Obtained or Produced Goods);	A
Produced entirely in the territory of one or more of the Parties using non-originating materials provided the good satisfies all applicable requirements of Annex 4-B (Product-Specific Rules of Origin);	B
Produced entirely in the territory of one or more of the Parties exclusively from originating materials; or	C

- FIELD 8** Include the period if the certification covers multiple shipments of identical goods for a specified period of up to 12 months as set out in Article 5.2 (Claims for Preferential Tariff Treatment) of Chapter 5 of the CUSMA/USMCA/T-MEC.
- FIELD 9** The certification must be signed and dated by the certifier. By signing this certification the certifier confirms they are familiar with Chapter 5 Origin Procedures, Article 5.2 and Annex 5-A of the agreement and the products listed qualify under CUSMA/USMA/T-MEC.
